PRESIDENT'S MESSAGE

As we step into 2024, I'm happy to share the significant strides made during the last few months and the exciting prospects that lie ahead.

Our progress towards the Final Investment Decision (FID) and the commencement of construction at Rhyolite Ridge has been substantial. With conditional commitments nearing US\$1.2 billion and key milestones achieved in the National Environmental Policy Act (NEPA) permitting process, we are well-positioned for the transformative year ahead.

In mid-January, we reached an important event in the NEPA permitting process as the Bureau of Land Management (BLM) completed the administrative draft Environmental Impact Statement (ADEIS). We anticipate publication of the Draft EIS following the conclusion of BLM management and cooperating agency reviews this quarter. Publication will mark the commencement of a 45-day public comment period, providing a valuable opportunity for your input. Keep an eye on our communication channels for engagement events and updates.

loneer has been diligently collaborating with the BLM and U.S. Fish and Wildlife Service to progress both NEPA and the Section 7 Endangered Species Act (ESA) processes simultaneously. We are confident in the timely completion of these processes, thanks to extensive preparation and cooperation over the past several years.

resource and quarry design based on the valuable data gathered.

Permitting Update

We are pleased to report that progress in the National Environmental Protection Agency (NEPA) permitting process for the Project is advancing steadily. In January an administrative Draft Environmental Impact Statement was completed and issued for review by federal, state, and local agencies. Upon completion of this review, the next significant milestone is the expected release of the Draft Environmental Impact Statement (DEIS), which is projected to be published and viewable to the public in the 1st quarter of this year.

The DEIS will offer all interested parties an opportunity to review the document and provide comment on various aspects of the Project's Plan of Operations including environmental conclusions, submitted alternatives, analyses conducted, the description of the affected area's environment, required mitigation measures for loneer, and detailed appendices supporting the reached conclusions. The DEIS is the culmination of years of review and coordination between loneer, federal and state agencies, and other cooperating agencies including local county governments.

Following the DEIS release, there will be a 45-day public comment period. We extend our gratitude to those

who provided comments during the initial scoping period and encourage ongoing public participation to ensure everyone's voice is heard. In addition to Bureau of Land Management (BLM) protocols, loneer will organize events for public engagement, providing further opportunities to review the DEIS, ask questions, seek clarifications from our loneer team members, and learn how to submit comments to the BLM.

To stay informed about event dates and details, we recommend regularly checking the <u>BLM's E-Planning</u> <u>site for the project</u>, loneer's website, mailings, flyers, local news publications, and other communication channels. We anticipate the NEPA process's conclusion with a Record of Decision (ROD) from the BLM in the third quarter of 2024, paving the way for construction activities to begin shortly thereafter. Our expectation remains that lithium and boron production will commence in 2026.

Meet Shelly Jackson – Ioneer's HR Generalist


